The Hudson County Prosecutors Office, Internal Affairs Division has requested a summary of disciplinary action which resulted in the loss of ten days or more for the calendar year 2019. The following is a summary of such investigations.

IAU File # 2018-148

A member of this agency made an unauthorized use of another members email which violated our general order policy (unlawful discrimination policy including sexual harassment).

Finding: Sustained

Penalty: Loss of 10 Days

IAU F# 2018-043 (Officer #1)

A member of this agency left his assigned district where he was engaged in an altercation with the manager of a business establishment. The officer was charged with various criminal offenses.

Finding: Sustained

Penalty: Suspended 74 work days

IAU F# 2018-043 (Officer #2)

A member of this agency left his assigned district where he was engaged in an altercation with the manager of a business establishment. The officer was charged with various criminal offenses.
