Jersey City Environmental Commission (JCEC) – Matt Trump

• After a discussion with Forester Ed O'Malley and Sustainability Director Kate Lawrence, the JCEC feels comfortable with direction of City and Forester

regarding tree management and planning. Recommendations from JCEC for next steps on inventory is for City to proceed as is.

• JCEC is also writing a letter of recommendation for the Hudson Essex Greenway.

Sustainable Jersey City (SJC) - Debra Italiano

- SJC is happy with the success of their tree mapping program and is gearing up for 2021 engagement and training. Wishes that they had a more formal partnership with City.
- In 2021, SJC will focus on their tree mapping initiative, tree-related legislation, and funding opportunities.

NEW BUSINESS

Forestry Standards

John McKinney, Legal Dept. - Review and comments on standards

- All suggested changes are embedded in digital document
- Change listed organization from Division of Parks & Forestry and other divisions to Jersey City.
- Question raised regarding relationship of document to Zoning and Planning.
 - o Planning and Zoning reference 345 all tied together.
- Concern about how Standards can be properly enforced without having Forester on staff
 - o Legal will look into this
- Question raised about tracking number and location of trees being planted by developers.
 - o Planning noted that this is not realistically possible given staffing
 - o Idea of tracking numbers through SDL portal
 - O Question raised is Forester was tracking all permits?
 - Only trees that deviate from standards
 - o Tracking all plantings is good goal for the future
- Question raised about whether Forestry Standards can be referenced in ordinance and development application.
 - o Forestry standards are currently referenced in Zoning Code
 - o We can add direct reference to Zoning application
 - o Idea raised of sending Forestry Standards to developers to make sure they are aware of standards
- Suggestion for inclusion of definitions section with Forestry Standards
 - o Should definitions be the same as 321?
 - o Legal noted that they should but could go further
- Question raised who is tracking MUA's tree plantings? Do we coordinate with state and county regarding trees in their parks?
 - O Not sure but this would be great information to have.

- Suggestion was raised to update approved tree species
 - o Can tree list be added to editable document?
 - O Yes for tree species table, no for engineering drawings.
- Question raised who is document for?
 - Suggestion to add other City agencies to this paragraph in the beginning of Standards
- Suggestion to add "these standards have the force of law"
 - o Legally, this is unnecessary but ok
- Suggestion to change "should" to "shall" whenever appropriate
- Discrepancy between 15 and 20 foot distance related to construction and barriers around trees.
 - o Needs to be changes to 15 feet throughout
 - Discussion as to why protection of trees during construction doesn't occur as required
 - o Suggestion to add item to developer checklist
- Question about planting plants around trees. Should this be allowed?
 - o Apparently lots of constituents have this question. Gray area.
 - o Planting flowers shouldn't happen during first two years of tree's life in order to ensure optimum water and nutrient absorption. Planting of shrubs shouldn't happen at all.
 - o Note to explore further
- Tree Removal Section
 - o Minor edits to language related to removal
 - Discussion of who makes determination if there is no Forester on staff handle in definitions?
 - o Removal criteria as determined by Forester
 - o Planning Board/Zoning Board approval for applications requiring a tree removal
 - o Add criteria related to sidewalk lifting
 - o All criteria needs to reference Forester approval in some way.
- Tree Replacements
 - Suggestion made for replacement trees to be planted next to dying trees whenever possible
 - Could be issue when an area is not suitable to tree success
 - Not appropriate strategy for planting street trees
 - Needs further discussion
 - Old growth trees need to plant multiple trees to make up for replacement of larger trees
 - Add clarifying language to plant elsewhere if site conditions are problematic?
 - o Can we have dedicated fund for planting trees?
 - Unfortunately this is not possible according to State law..
 - O Suggestion made for replacement street trees to be planted close to where trees have been removed.

- Will help to avoid situation where some neighborhoods have no trees
- This is problem in Journal Square neighborhood.
- We can add language that replacement tree will be planted as close as possible to tree that they are replacing.
- O Question raised how is value of tree determined?
 - Industry standard referenced by Forester is recommended as best approximation.

PUBLIC COMMENT

Caroline Katz-Mount – Noted that she is very pleased with process

OPEN DISCUSSION

- Discussion of next meeting date
 - o Needs to be moved to February 22 because of President's Day holiday.
 - o Suggestion made to meet sooner.
 - Additional suggestion made to have interim working meeting before next public meeting.
 - o It's possible not everyone can attend. Several dates were suggested. Interim meeting date will be discussed offline.
- Request was made to include questions from STC member email in minutes.
 - o It was noted that meeting minutes are for what occurs during a meeting
 - o Answers to questions are not always immediately available.
- Suggestion made that edits to and discussion of Forestry Standards should be public process, not something that occurs during working meetings.
 - o Legal advised that this does not accommodate time constraints and offline conversations can be covered quickly during public meetings.
